Academicians **as full paper** in the field of Plant physiology, Plant Ecophysiology, Plant molecular biology and Plant biotechnology with **physiological approaches**. Papers submitted by the authors/ co-authors must be original in nature and no parts of the submitted paper are not currently sent to any local or international journal.

Manuscripts should be submitted online to the journal at: <http://www.jispp.ir> .Once a manuscript has been accepted for publication, it will undergo language copy editing, typesetting, and reference validation in order to provide the highest publication quality possible.

Journal of Plant Process and Function will publish only Original Research Articles. Review, Case reports and Letter to the Editor are not accepted. Research work or all articles should be submitted in English language. Other language will not be accepted .

Original Research Articles

Research Articles must be typed and all pages are to be numbered. Title page must include full name of the author, phone number, mobile number and e-mail Id and present address. The abstract state that the scope of research and point out materials and methods, findings and conclusion. The abstract must be in complete sentences, verbs should be clear and abstract should be written in the past tense. Five to ten key words will be provide index reference should be listed .

Introduction

Introduction must be in clear & stating that reasons for carry out of research work, background regarding the research nature of hypothesis should be clearly stated. The introduction should be understandable to reaches from various science disciplines.

Materials and Methods

Materials and methods do not refer to common place statistical test. It must be enough to allow experiments to be reproduced. If any previous published research work can also be cited and notification should be mentioning clearly. Subheadings should be used.

Results

Results of research articles or manuscripts should be present with clarity and precise .Previous publisher's findings should be written in present tense. Results should be explained. Discussion, interpretation should be included in the results but should be put into the discussion section .

Discussion

Discussion part of the research paper includes the sub heading, significance of the results related to research work. In some cases Result and Discussion might be together .

Acknowledgments

This section should be thanks to people, granting body, university departments, college departments should be in a brief manner .

Tables

Tables and chart in the research paper should be kept minimum and simple. It should be double line space including the heading and foot note. Table should be presented in text .

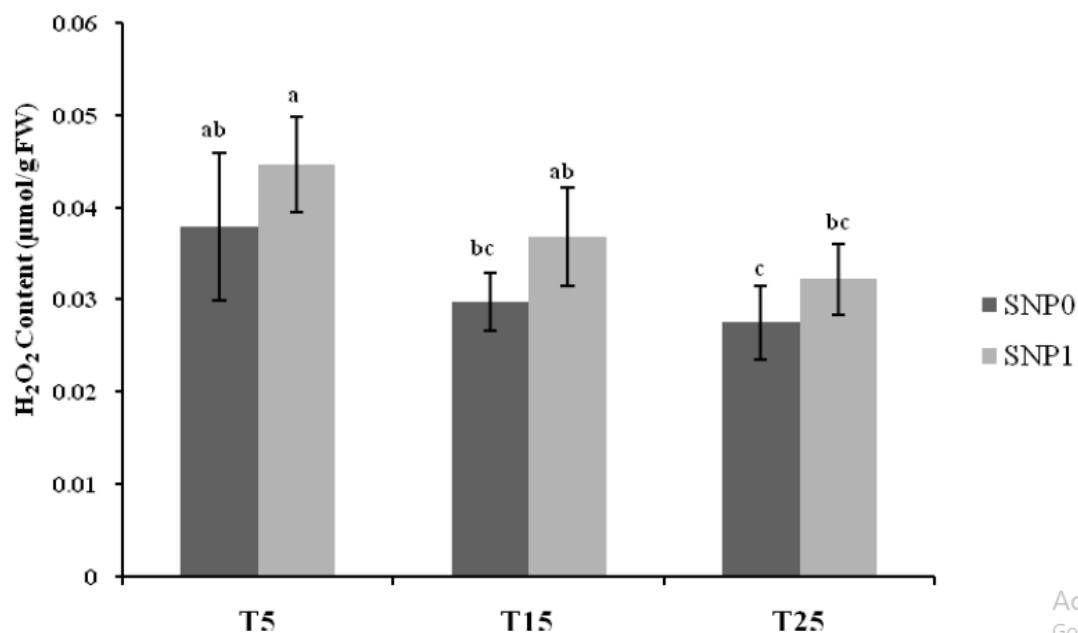


Figure legends

Figures should be presented in the text similar to the following example. Axis (X and Y) should be **Times New Roman 10, Bold** .

References

In the text, a reference identified by means of an author's name should be followed by the date of the reference in parentheses. When there are more than two authors, only the first author's name should be mentioned, followed by 'et al.,'. In the event that an author cited has had two or more works published during the same year, the reference, both in the text and in the reference list, should be identified by a lower case letter like 'a' and 'b' after the date to distinguish the works .

Proofs and Reprints

Electronic proofs will be sent (e-mail attachment) to the corresponding author for final proof. Page proofs are considered to be the final version of the manuscript. With the exception of typographical or minor clerical errors. Authors will have free electronic access to the full text (in PDF) of the article. Authors can freely download the PDF file from which they can print unlimited copies of their articles.

Copyright

Submission of a manuscript implies; that the work described has not been published before (except in the form of an abstract or as part of a published lecture, or thesis (that it is not under consideration for publication elsewhere; that if and when the manuscript is accepted for publication, the authors agree to automatic transfer of the copyright to the publisher .

Fees and Charges

Authors are required to pay 150000 TOMAN as a part of processing fee. Acceptance or rejection of a manuscript is independent of fee payment.

Abstract [**Times new roman and 10 Bold**]

Introduction [**Times new Roman and 11 Bold**]

This section should be brief described the background and aim(s) of the work [**Text 10 point with times new roman**]

Materials and Method [**Times new Roman and 11 Bold**]

This section need to describe research materials and method. [**Text 10 point with times new roman**]

Results and Discussion [**Times new Roman and 11 Bold**]

This section need to describe experimental results and analysis result. [**Text 10 point with times new roman**]

Conclusion [**Times new Roman and 11 Bold**]

This section need to include overall full original work. [**Text 10 point with times new roman**]

Acknowledgments [**Times new Roman and 11 Bold**]

Acknowledgments should be included at the end of the paper and before the references. It may also include supporting grants, private money, and etc. [**Text 10 point with times new roman**]

References [**Times new Roman and 11 Bold**]

References section need to write down like [1] Authors name, paper title, journal name, vol., no., year, page no., references should be cited within the text in number wise. [**Reference text 10 point with times new roman**]

Figure and Table's

Figure and Tables should be cited serially in the text area with number. No vertical or horizontal lines except for heading in the table .

Plagiarism Policy

This journal aims to publish original high quality research work. Submission of manuscript to this journal indicates that the study has not been published anywhere or not been submitted elsewhere for publication. If author(s) are using any part of published paper (in English or any other language), they should give proper reference or in any case, if required they should get permission from the previous publisher or copyright holder (whichever is suitable).
